2009-10 TOURNAMENT PROCEDURES FOR NON-SRVA TEAMS

I. TO VIEW AVAILABLE TOURNAMENTS

- [1] Go to the SRVA website -- www.SRVA.org
- [2] Click on Tournament Calendar under the junior column of buttons [the junior column is the far right column]
- [3] At the next screen, select gender, level(s), division [Power, Club, Regional in junior division competition] and date, then click on view to see all tournaments that fit your selections. You can also click on view without selecting any of the above categories to see all approved tournaments.
- [4] Click on "Event" and "Contact" to see additional information about the tournament, such as local host information [PAID REFEREE provided ONLY if listed]

II. TO ENTER A TOURNAMENT

OUT OF REGION JUNIOR TEAMS –

- [1] complete, print, and sign the attached form
- [2] mail the form and entry fee [made out to SRVA] to the address on the form
- [3] When paying by paypal, be sure to put your club name on the payment
- [4] Complete the roster page and send with coach to the tournament

III. TO CHECK THE STATUS OF YOUR ENTRY

When viewing your team status on the "SRVA Online" portion of our website, please note, "approved" means your team is fully registered for the tournament, (i.e., signed, fully-completed entry and money have been received by SRVA) but your team is not yet accepted until final court assignments are made. Also be aware, once court assignments are made unforeseen changes may occur in gym availability, bad weather may occur, etc., so check the site regularly, especially during the two weeks prior to the tournament.

You will be able to find out the other teams that are in the tournament. Directions to tournament sites are available under the venues section of the SRVA website.
